These activities include managing an Annual Fund that is comprised of gifts from businesses, foundations, and individuals. The SLPL Foundation staff are community advocates, developing partnerships to further the library's mission and build community support for library programs and services. As of September 30, 2017, the Foundation managed an Annual Fund, which had gifts from 1,627 businesses, foundations, and individual donors. In addition to managing the Annual Fund, the Library Foundation executed one fundraising event involving 125 guests, raised funds for exhibits and cultural programming, managed invested funds used for SLPL programs, and held Friends stewardship events. The SLPL Foundation promoted the St Louis Public Library through a quarterly E-Newsletter to 3,500, social media posts, and print and radio advertising.
